##### **18.00 – 20.00 Opening Coffee Shop & Vienna Deaf Community HIV/AIDS Outreach**

We welcome all organisers and participants of the Disability Zone to join us for an opening Coffee Shop. Meet the other presenters and activists, and receive important information on the programme for the week.

John Meletse shares his own experience of being diagnosed with HIV seven years ago. He will present his work with GALA, his experiences teaching Deaf learners in Soweto and distribute copies of the comic he created for this purpose.

A workshop on prevention, management and access issues for those living with disabilities and HIV in East Africa led by Dr Emmanuel Luyirika, director of the Mildmay Centre, a leading HIV care, treatment and training facility in Kampala, Uganda, and Dr Stephen Watiti, an HIV-positive clinician, author and passionate advocate for HIV rights.

##### **15.00 – 16.00 Film “The Voice of 650 Million x1”**

In this documentary produced by VSO, inspiring people with a disability in Asia and Africa show their world of exclusion regarding sexuality, HIV and reproductive health. This is a courageous and touching documentary portraying those who've been forgotten by governments, donors and NGOs. The 35 minute screening will be followed by a discussion with Jessica de Ruijter (VSO NL) and Wanjiru Mukoma (Liverpool VCT, Kenya).

**16.00 – 18.00 Facilitating discussion groups that empower people with disabilities about sexual health, sexual violence and HIV-AIDS prevention**

Sexual Understanding works with persons with disabilities, their families and professionals to provide information and training on sexual health, sexual violence and HIV-AIDS prevention.

**Tuesday 20<sup>th</sup> July**

**10.15 – 11.00 Reality Kick – Blindness and HIV**

*Zambia National Library & Cultural Centre for the Blind*

Joseph G N Mutale, Executive Director, will share with us their work in the psycho-social rehabilitation of persons acquiring blindness through AIDS, and their programs to equip those with newly-acquired blindness with skills in Braille, mobility, orientation and personal management.

**12.00 – 14.00 The disabling effects of HIV - A new agenda for policy makers**

Many families are coping with the impacts of AIDS-related disabilities. There is, however, very little research in sub-Saharan Africa which investigates the impacts of adult disability on *children* in the home. This study uses data from 1000 matched carer-child pairs in Kwa-Zulu Natal, South Africa to ask whether the extent of adult disability predicts children's domestic work, school attendance and mental health. Discussion will be lead by Marisa Casale (HEARD) and Caroline Kuo (Oxford University).

**14.00 – 16.00 Film “Stepping into the Unknown”**

This documentary tells the story of four disability and HIV activists who took the plunge at the world's highest swing in South Africa in an attempt to raise awareness for the interrelations of disability and HIV. Using the jump as a metaphor the film explores how confronting your fears enables you to be in control provided you got the necessary assistance. Because of the double stigma associated with disability and HIV disclosing a positive status might be even more difficult. Stepping off the cliff symbolises stepping away from stigma and fear. Discussion with Phillimon Simwaba (DHAT), John Meletse (GALA), and Jill Hanass-Hancock (HEARD)

**16.00 – 18.00 Developing the full potential of quadriplegics and paraplegics**

QASA will present their *Rolling Positive* program, funded by the Global Fund, which aims to train persons with disabilities as peer educators and lay counsellors on HIV-AIDS and STIs. The discussion, with Phillip Coetzer, Siphon Mdletshe and Vernon Openshaw, will focus on lessons learned regarding Sexuality and Disability and on life enhancing programmes

**18.00 – 20.00 Stopping the Brain Drain: Confronting the issues of HIV-related neuro cognitive impairment (HNCI) head on**

Dr Simon Rackstraw, medical director of Mildmay UK, Europe's only specialist HNCI rehabilitation unit, based in East London, uses his experience and expertise to offer real insight into this little known and often misunderstood effect of HIV and how Mildmay is striving to tackle it.

**Wednesday 21<sup>st</sup> July**

**10.15 – 11.00 Reality Kick – Intellectual Disability and HIV**

*Toyin Aderemi, PhD Nigeria*

In Nigeria, little is known about the vulnerability of intellectually impaired learners (IIL) to HIV infection. This presentation is based on a study which investigated HIV knowledge and sexual practices among mild/moderate IIL and mainstream learners in Nigeria. Findings point to the relevance of parents in HIV education for learners. The presentation will discuss the selected results from the study and present a Sexuality and HIV Education Manual developed for people with intellectual disabilities.

**11.00 – 12.30 Physical and Cognitive Rehabilitation Following Complications of HIV Disease: Designing and Delivering Services in Different Settings**

This workshop explores the challenges facing communities in managing the needs of people living with HIV in settings where treatment is now becoming available, and are therefore living longer, but with potential HIV related impairments and disabilities. The presenters are rehabilitation professionals from a range of settings.

**12.30 – 13.20 Activists with Disabilities Speak out on HIV/AIDS: A Panel Discussion**

People with disabilities, including deaf people, are a priority and under-served population and yet many AIDS activists and service providers and most of the general public do not know the issues facing disabled people around HIV/AIDS. Three activists with disabilities will share their experiences as people with HIV or working closely with HIV/AIDS populations and discuss the issues that affect people with disabilities.

**14.00 – 15.30 Inclusion for all: An innovative approach to HIV and STI prevention among children with disabilities**

Karen Sodoma of World Vision Canada will share best practise and lesson's learnt from World Vision's first Disability/HIV program in India. World Vision are partnering with local disabled people's organisations, the government, healthcare workers and school leaders to ensure persons with disabilities are included in HIV programs.

**15.30 – 16.30 Film "Disability and HIV/AIDS in Uganda"**

This short film illustrates the challenges faced by persons with disabilities in Uganda to access HIV-AIDS prevention, care and support. Martin Babu Mwsigwa (NADPU) will introduce Kwagala Betty Babirye, a Ugandan woman with a disability living with HIV who will share her experiences.

**16.30 – 18.00 Community Based Rehabilitation for people living with HIV and Disability**

Mr. Ramlal Prasad will present the current scenario, challenges and opportunities in community based rehabilitation of persons with disabilities living with HIV/AIDS in rural areas. He will share the magnitude of the problem in the context of India and suggest possible intervention strategies to overcome the challenges and tap the existing opportunities.

### **18.30 – 20.30 AIDS and Disabilities: Country Level Perspectives**

This satellite session aims to increase awareness and knowledge about programmes on AIDS and disabilities, and present opportunities for strengthening the linkages between the two. It will discuss the need for enhanced collaboration between development actors, donors, national partners, and civil society etc. to foster the proliferation, integration and development of inclusive HIV prevention and AIDS programs for persons with disabilities.

## **Thursday 22<sup>nd</sup> July**

### **7.30 – 8.30 Advancing AIDS and Disability responses: monitoring and evaluation strategies**

With the entry into force of the Convention of Rights of People with Disabilities, the UN Agencies, international cooperation bodies and National Governments have the mandate to ensure inclusive development strategies that benefit people with disabilities and other disadvantaged groups. Over the last three years SICA-SISCA has lead a process of developing capacities to address the challenge of including people with disability in HIV/AIDS interventions. This meeting will be important to disseminate knowledge and explore bridges between data and participatory programming.

### **10.15 – 11.00 Reality Kick – The Disabling Effect of HIV**

This presentation will discuss HIV/AIDS as an Episodic Disability and its implications as well as the role and opportunities for rehabilitation in addressing health related challenges faced by people living with HIV/AIDS.

The UN Convention on the Rights of Persons with Disabilities came into force in international law in 2008. In the same year, the Mexico City AIDS conference was the first IAC to include disability issues in the main conference programme. Two years later, this session asks "Where are we now?" Notable AIDS activists, disability advocates and human rights campaigners will gather for an interactive session to review and analyze progress made and obstacles encountered in the push to fulfil the vision of the CRPD in the field of HIV/AIDS.
